Previously Opening Permission has been accord for Classes I to V for the year 2003-2004 in Proceedings Rc.No: 230/C7/2002, dt. 04-12-2002 of the District Educational Officer, East Godavari, Kakinada. The Correspondent has submitted the application for Provisional Recognition for Classes I to V in the School for the year 2003-2004 to 2007-2008 in the letter reference 2nd cited. The Deputy Inspector of Schools, Urban Range, Kakinada has verified the application for Provisional Recognition with reference to the condition laid down in the permission orders and G.O.Ms.No: 1 Education, dated 01-01-1994. The District Educational Officer, East Godavari, Kakinada is hereby accords Provisional Recognition for a period of Five (05) Years, Commencing form the academic year from 2003-2004 to 2007-2008 for Classes I to V (E. M) subject to the fulfillment of following conditions in respect of Vidyanjali English Medium School, Kakinada without aid from Government.

- 1 that the Society shall abide by the instructions or rules and regulations made by the Government or Authorized Officer from time to time.
- 2 that the Educational Institution shall serve the needs of the locality more particularly.
- 3 that the Institution shall adopt the curriculum and syllabus prescribed by Government from time to time
- 4 that the school timings, vacations and mid-term holidays shall be as prescribed by Government from time to time.
- 5 that the Qualified staff within the age limits prescribed by the Government Employees shall be appointed as per the staff pattern.
- 6 that the results of Institution shall be satisfactory every year.
- 7 that the record & accounts shall be furnished to the District Educational Officer every year by 30th September at least.
- 8 that the list of Governing Body shall be furnished to the District Educational Officer every year.
- 9 that the Pay structure or Fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10 that all the conditions prescribed in the G.Os and other orders which are not specified in this order shall be complied with.
- 11 that the school shall be closed without giving notice both to the parents, District Educational Officer and competent authority at least six months before.
- 12 that the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
- 13 that the society shall submit proposals for Provisional or Renewal of Recognition sufficiently in advance (i.e.) at least six months prior to the date of the present recognition.
- 14 All the appointments should be regulated as per norms stipulated in G.O.Ms.No:1 Education, dated: 01-01-1994.
- 15 Other conditions as per GOMS No: 1 Education, dated: 01-01-1994 should be followed from time to time.
- 16 Roll should be improved and appointment should be revised as per rules.
